

Central Inspection Framework for Industries



Inspections: Synchronized and Simplified

Central Inspection Framework for Industries is a first of its kind inspection framework in India, designed by the Government of Odisha with an objective to ensure clarity on inspections, frequency of inspections, and reducing duplications. This framework aims at bringing transparency and accountability in inspections and ensures synchronized inspections for Directorate of Factories and Boilers, Labour Department and Odisha State Pollution Control Board (OSPCB).

Operational Framework: Synchronized Central Inspection Framework has been designed to schedule inspections that will draw inspectors from OSPCB, Labour department and Directorate of Factories and Boilers in each district, listing out all the establishments in the district and then scheduling the inspections for an establishment by a specific inspector.

Computerized Risk Based Inspections: The inspections scheduled in based on this framework will be based on the risk profile of the establishment being inspected. Each department party to this framework has defined various risk criteria and based on them all the establishments in the state have been allocated a risk rating. The online system identifies the establishments randomly based on the risk profiles allotted to them for inspections. This ensures a transparent and objective method for selection of establishments for inspections.

Random Allocation of Inspectors by the System: The allocation of inspectors to inspect the establishment is decided by the online system in a random manner. It is also mandated that the same inspector cannot undertake inspection of the same establishment twice consecutively. This ensures an open and fair system for inspections to be carried out.

Prior Intimation of Inspection via email and SMS: After the schedule is created by the online system, to further ensure the transparency of the process, prior intimation will be sent to the establishments via their registered mobile numbers and email addresses. This will ensure that there are no surprises for the establishment and enable the smooth conducting of the inspections.

Timely Inspection Reports: The Central Inspection Framework not only ensures a transparent inspection process but also ensures that the activities are carried out in a timely manner. The system ensures that the inspection reports are available on the online portal for the establishment to login and download, within 48 hours of completion of the inspection.



The Government of Odisha through resolution No 193734000120153844/I dated 10.06.2015, has constituted a Central Inspection Co-ordination Group as part of "Ease of Doing Business" framework for improving the inspection framework with an objective to ensure clarity on inspections, frequency of inspections, and reducing duplications. This Inspection Framework aims to achieve the objective of simplifying business regulations and bring in transparency and accountability in inspections and ensure synchronized inspections of Factories & Boilers, Labour Department and Odisha State Pollution Control Board (OPCB) based on risk based assessment.
