

AGENDA ITEM NO: 3

Proposal of M/s Suguna Foods (P) Ltd for setting up a frozen poultry meat unit at- Khordha Industrial Area, poultry feed unit at- Deras Sea Food Park Bhubaneswar and another poultry feed unit At- Bhadrak, Dist-Bhadrak with a total investment of Rs.50.27 crores.

After detailed discussions, SLSWCA in principle approved the proposal of the company for setting up a frozen poultry meat unit in Khordha District, poultry feed unit at- Deras Sea Food Park and another poultry feed unit Bhadrak, District, subject to the following terms and conditions:

- 1. The company will clear arrear dues, if any, of any Government Department before allotment of land for the project
- The company may plan to source live birds and other raw materials from Odisha. No raw material linkage / assurances from the State Govt. for the project shall be provided
- 3. The project should not be located on mineral bearing area or command area of any irrigation project.
- 4. The company will submit detail land use plan. Allotment of land to the project is subject to assessment by IPICOL (considering the bench mark report where ever available) or as required by the company, whichever is lower. The company will follow the prescribed procedure of IDCO for final allotment.

SLSWCA noted the requirement of land for creation of various facilities for the project as projected by M/s JSW Steel Ltd. vis-à-vis MECON's assessment. The final figure was arrived at based on "whichever is lower". The land assessed for Integrated Steel

Plant was 2980 acres and 1025 acres for Grinding-cum-Beneficiation Plants respectively. Assessment of the balance facilities was deferred for further assessment. MECON was advised to revisit requirement of land for the township by planning high rise apartment blocks.
