#### **NOTIFICATION**

The following stagewise timelines are prescribed for processing of fresh/Modified applications received for granting of Manufacturer/ Dealer/ Repairer & Registration of Packer licenses under the Legal Metrology Act, 2009 & Rules made there under and in confirmation to the timeline notified in Odisha Right to Public Services Act, 2012 for such services.

### **Maximum Processing Time:**

- Initial Processing (ILM/ACLM): 20 days
- District Level Officer (DCLM/JCLM/SJCLM): 10 days
- Granting Authority (Controller, LM): 15 days

### **Application Returns:**

- o Applications can be returned to the applicant for further compliance with a maximum of two times at each level(ILM/ACLM, District Level Officer, Granting Authority) for necessary compliance, if any - totalling a maximum of 6 times returns.
- o Time spent with the applicant for corrections does not count towards processing time.

## **Application Rejection:**

o If the applicant does not resubmit the application within 60 days of being returned from any level, or fails to comply with corrections after the maximum number of returns, the application may be considered rejected.

The above process shall be in place with immediate effect and supersedes all orders/communications issued in this context.
