Subject: Amendment of Industrial Policy Resolution (IPR) – 2015

Industrial Policy Resolution (IPR) - 2015 came into force vide Industries Department Resolution No. 5700/I, dated 24th August, 2015 with an objective to broad base industrial development in the State through effective and need based incentives and facilitation services.

Consequent upon outbreak of second wave of COVID 19 pandemic and keeping in view of the present surge in the number of Covid patients with low oxygen level, the demand for medical oxygen has increased multitudinously. In order to meet the increasing demand for medical oxygen, it is required to incentivise the production and refilling units.

Under the provisions of Para 14 (f) of IPR – 2015, Government have been pleased to amend the provisions of the IPR – 2015 with effect from the date of notification of this resolution as follows:

1. Amendment of Sl. No.39 of Negative list i.e. Sub-Para 3 of Para 16. Annexure-II of IPR 2015.

Oxygen refilling unit is considered as eligible unit by amendment of Sl. No.39 of Negative list i.e. Sub-Para 3 of Para 16. Annexure-II of IPR 2015 as ***'Repackaging units except medical oxygen refilling/repackaging'***.

2. Addition of Manufacturing/refilling of Medical Oxygen and/or its Container in Sl. No. 18(v) of Priority list i.e. Para 15. Annexure-I of IPR 2015.


Addition of activity ***"Manufacturing/refilling of Medical Oxygen and/or its Container"*** in Sl. No. 18 (v) of Priority list at Para 15. Annexure-I. (Definition and Interpretation) of IPR 2015.

Further ***"Manufacturing/refilling of Medical Oxygen and/or its Container"*** is being added in Para. 5 (v) of the Operational Guideline for grant of Priority sector status under IPR-2015.
