# OPERATIONAL GUIDELINES FOR ENVIRONMENTAL PROTECTION INFRASTRUCTURE SUBSIDY UNDER ODISHA STATE FILM POLICY 2019

# (See Para 11.8 of OSFP, 2019)

# 1. Short Title

Operational guidelines for Environmental Protection Infrastructure Subsidyunder Odisha State Film Policy 2019.

# 2. Commencement

It shall come into force from the "Effective Date" of Odisha State Film Policy 2019 i.e. March 2, 2019

# 3. Terms and Expressions

- 1. "Project" means Film Cities, Cinema Halls and Multiplexes as per definition at Annexure I of the policy.
- 2. Terms and expressions used in this operational guideline, but not specifically defined / explained here, shall have the same meaning as in Odisha State Film Policy 2019.

### 4. Definitions / Explanations:

Effluent treatment plant / Sewerage Treatment Plant means recycling, re-use in operational/ or domestic purpose or evaporate without discharge to outside the premises but exclude for use in irrigation, horticulture, injection/ charging into ground water table.

### 5. Policy Provisions

### Environmental protection infrastructure subsidy (Para 11.8 of OSFP 2019)

New projects shall be eligible for reimbursement of 20% of the capital cost of setting up Effluent Treatment Plant / Sewerage Treatment Plant subject to a ceiling of INR 20 lakh. Such reimbursement shall be made only after commercial operation of the project.

# 6. Eligibility:

Projects satisfying the criteria and falling under the following category shall be eligible for the incentive-

6.1 New Film Cities, Cinema Halls and Multiplexes as defined in the OSFP 2019 shall be eligible for the incentive.

6.2 Multiplexes and cinema halls in within the limits of the municipal corporation areas of Bhubaneswar and Cuttack shall not be eligible for any incentives.

6.3 Project must have been approved by the State Level Committee/ Competent Authority under the extant of The Orissa Cinemas Regulation Act 1954

6.4 The Date of Operation for the project should be after the "Effective Date" of Odisha State Film Policy 2019.

6.5 Promoter should not have availed similar incentives, under any other scheme of the State Government for the project.

# 7. Time frame for filing application:

Eligible projects shall file its claim complete in all respect within one year of approval of project from State Level Committee/ Competent Authority under the extant of The Orissa Cinemas Regulation Act 1954.

# 8. Procedure:

**8.1** Projects satisfying the eligibility shall file application in the prescribed form appended to this operational guideline at Annexure -"A" along with copies of all relevant documents as mentioned in the Checklist at Annexure -"B"and Undertaking prescribed at Annexure A-1 with General Manager, RIC /DIC. Copies of the documents as indicated in the checklist shall be self - attested by Proprietor / Managing Partner / Managing Director / Authorized Signatory.

**8.2** On receipt of application, the acknowledgement as prescribed at Annexure- "C" shall be dispatched to the applicant / applicant unit duly signed by the authorized officer / General Manager, RIC / DIC on the day of receipt. General Manager, RIC / DIC may authorize any of his officers for the purpose.

**8.3** After receipt of the application, **RIC** / **DIC** will check the eligibility and veracity of facts concerning the claim and transmit one set of application with relevant documents indicating the date of operation to the concerned authorities to State Pollution Control Board (SPCB) for certification of the STP/ETP within **7 days** from the date of receipt of application who has to furnishing the certificate on total Pollution Control Equipments in the format as at Annexure – D under intimation to the concerned unit.

**8.4** The SPCB has to furnish the required certificate in prescribed format at Annexure- D within next 15 **days** to Director of Industries, Odisha under intimation to concerned RIC / DIC.

# 9. Sanction:

**9.1** Sanction of eligible amount of Environment protection infrastructure subsidy may be accorded in favour of eligible Unitsby a Special Sanctioning Committee constituted as below;

"Special Sanctioning Committee (SSC)" means a committee comprising of

9.2 The sanction order will be communicated to the project within 7 days by Director of Industries in the format as prescribed in the **Annexure-E**.

#### 10. Disbursement:

Disbursement of sanctioned amount for Environment protection infrastructure subsidy shall be made by Director of Industries, Odisha within 7 days of sanction

# 11. Rejection:

In case of rejection of application, the reasons of rejection shall be communicated to the applicant unit within 30 days of determination of eligibility by the respective agencies in the format prescribed at Annexure – "F".

#### 12 Recovery:

The amount disbursed towards Environment protection infrastructure subsidy and or any part thereof shall be recoverable with penal interest of 24% per annum from the date from which the subsidy is availed.

- A. If the information furnished is found to be false/ incorrect / misleading or miss-represented and there has been suppression of facts / materials or disbursed in excess of the amount actually admissible for whatsoever reason.
- B. If the project goes out of operation for a period exceeding six months at a time for any reasons other than labour troubles, want of electric power or for the reason which is beyond the control of entrepreneur / management during the period of incentives.
- C. If any part of Equipment and Machinery is disposed of and not reported which affects the maximum limit of Environment protection infrastructure subsidy during the period of incentives.

The eligible units under the scheme may be identified by RIC /DIC / DI Odisha well in advance. If any unit is found to be deliberately furnishing wrong / false information, the incentives provided shall be withdrawn from under intimation to Industries Department / Director of Industries, Odisha / General Manager, RIC / DIC as the case may be.

#### 15. Miscellaneous:-

**10.1** RIC / DIC / Director of Industries, Odisha / OFDC/ OSPCB may inspect the project individually / jointly, if felt necessary.

**10.2** The amount of exemption on Stamp duty allowed shall be recoverable with penal interest as decided by the authority if the information furnished is found to be false/ incorrect / misleading or misrepresented and there has been suppression of facts / materials or allowed in excess of the amount actually admissible for whatsoever reason.

**10.3** Time limit prescribed in this guideline is of working days only.

10.4 Where any doubt arises regarding implementation of these Operational Guidelines, the same shall be referred to Government of Odisha in the Industries Department whose decision shall be final and binding on all the parties.
